2. Accounts are finalized on the business of Ledger & Bank Statement & I & E A/c & Balance Sheet as on 31.03.2015 by CSI Chapter.

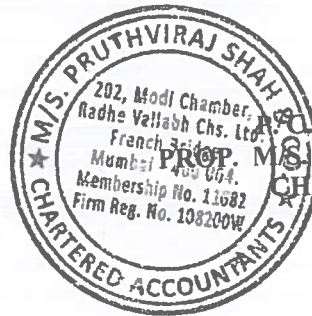
