3. Xerox of FD Receipts are not provided. Hence could not be verified, including accrued interest till date. FD o/s of 1 lac. is not verified as documents not provided.

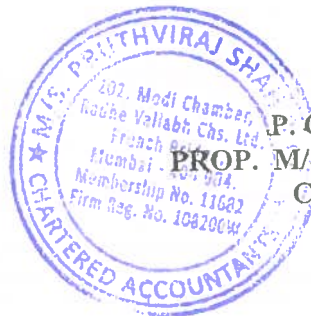


