# Annual Report for the year 2006-2007

Dear Members,

I have great pleasure in presenting this Forty Second Report of the Computer Society of India for the year 2006-'07.

The Indian economy during the year 2006-'07 continued its trend of robust growth on the back of strong performance in key industrial sectors, paving the way to rapidly emerge as a major economic power in the years to come. The year has been a significant and successful year for the Computer Society of India in terms of achieving various performance milestones which it had set upon itself at the commencement of the year.

## Operational Highlights

1. The Executive Committee (ExecCom) of the Society consisting of seventeen elected members and the immediate past President, entrusted with the responsibility of successfully running the Society met five times during the year at various locations across the country to review the functioning and activities of the Society and take decisions on important matters. The members of the ExecCom attended these meetings as follows:

Mr. S R Karode was elected Hon Treasurer (2006-'07) but due to certain problems tendered his resignation from the elective post and hence Mr. C D Murthy of Hyderabad was nominated Hon Treasurer (2006-'07) filling in the vacancy. However, Mr. Murthy after attending just one ExecCom meeting had to temporarily move to the US and hence resigned. Mr. Satish Doshi was nominated Hon Treasurer in November 2006 for the remaining term of office for the year 2006-'07.

Ms Lynette Saldanha, RVP-VIII (International) is based in New Zealand and hence could not attend the ExecCom meetings.

The Corporate Officers who are entrusted with the responsibility of conducting the day to day operations of the Society on behalf of the ExecCom had also met from time to time depending on the exigencies to consider important matters and ensure implementation of decisions in accordance with the strategic directions and policies of the ExecCom.

2. Some of the Regional Vice Presidents conducted regional meetings of their Chapters which facilitated interaction between them and the concerned Chapters and Divisional Chairmen. Additionally, the Regional Vice Presidents and Divisional Chairmen also met the Chapter representatives during the CSI Annual National Convention held in November 2006 at Kolkata which provided them an opportunity for mutual interaction and drawing of plans for organizing conferences, seminars and workshops at various locations in association with the local Chapters.
3. The National Council of the Society consisting of the ExecCom members and Chairmen of Chapters normally meets once a year to review the functioning of the Society. Accordingly, the Council met during the CSI Annual National Convention held in November 2006 at Kolkata.
4. The forty second Annual General Meeting of the Society was held on 24th November, 2006 at Science City, Kolkata, the venue of the CSI-2006 Annual National Convention.
5. The CSI Think Tank is a core group of past Presidents and Fellows of the Society most of whom are very eminent and highly experienced professionals. The Think Tank normally meets the ExecCom during the CSI Annual National Convention and accordingly the group met the ExecCom on 23rd November, 2006 during the CSI-2006 Convention and gave valuable advice, guidance and suggestions some of which were as follows:
  - a) The objectives of CSI are all encompassing and hence the areas of primary and secondary focus must be identified.
  - b) Needs of potential and regular members should be assessed regularly and value to members should be enhanced. A model of survey should be considered. Concerted efforts should be made

to enrol IT professionals who can take ahead the mission and vision of CSI in tune with the growing pace of IT industry. Have a mix of media tools to attract the young and potential IT professionals. Institutions and academicians should be closely associated with CSI.

- c) Presently the cost of services to CSI Life Members is much more than the Life Membership fee paid by Life Members. A workable solution to overcome this problem will have to be considered.
- d) Efforts should be made to involve Academicians in the activities of Education Directorate which should establish itself as the highest level certification and accrediting institute and expanded to more job market skills. Also, the Directorate should have a number of faculty persons to give advice on project to project basis.
- e) One National Student Convention should be held every year. The society should provide counselling and also assist in projects. Regular lectures by specialists should be conducted on fixed dates.
- f) Consider introduction of web based courses.
- g) Inter-disciplinary winning ideas and good content should be integral part of CSI. Good content should be available on the website.
- h) Voluntary services is the main principle and foundation of the Society. Members should fix up targets and have module to measure their work and activities to enable them to assess the achievement of their goals. Members should write articles regularly.
- i) CSI's nine TC (IFIP) Representatives must provide a leadership role in IT.
- j) Check the non-accountability of Chapters and Regions. There should be better pooling and sharing of resources from Chapters.
- k) The theme of Entertainment Computing may be considered.
- l) Get international IT events to India.
- m) E-governance Awards should continue.

The ExecCom has already implemented most of the above suggestions and also initiated steps to implement the other suggestions.



**Membership Highlights**

The success of any professional society like CSI primarily depends on the quality of the activities it conducts for the benefit of its members. Growth in membership is, to a very large extent, a reflection of the quality of activities conducted which provides satisfaction and thus acts as a driving force to attract new members. It is a matter of satisfaction that there was an all-round increase in membership during the year. The total membership increased from 30,186 as on 31.03.2006 to 37,513 as on 31.03.2007 i.e. an increase of 24%. While there was increase in every category of membership the increase in student membership in particular, was very significant as can be seen from the following Tables – 1, 2 & 3 which give membership details for the last five years.

Though the membership has increased it is definitely not a cause to be complacent as the ExeCom is strongly of the view that the increases achieved are insignificant considering that there are hundreds of thousands of IT professionals and students spread across the country and there is tremendous scope to increase our membership many fold with some more efforts, especially by the Chapters. In this context the ExecCom wishes to record its appreciation of the vigorous efforts made by some Chapters who were successful in increasing their membership.

### **Honorary Fellowship**

During the year the Society with pride and pleasure conferred its Honorary Fellowship in absentia on Prof. Harold D Huskey in grateful recognition of his pioneering role in the field of Computer Science and Education and visionary contribution in bringing together the young computer professionals in India into a forum for gainful exchange of Information and experiences, which led to the formation of the Computer Society of India.

For the information of members who may not be well aware of Prof Husky who is a very distinguished and eminent person, it is to be briefly mentioned that though he was based in USA he had spent two years (1964-65) in India under the USAID Programme to support the establishment of Indian Institute of Technology, Kanpur and the Ford Foundation Programme at the Delhi University, establishing the Computer facilities and initiating Computer Science programmes. Prof Husky was an active participant in a meeting of Computer user organisations and scientists in India held at the IBM Education Centre, Faridabad on June 4, 1964 which conceived the idea and formed the All India Computer Users Group (AICUG) to bring all the individuals together and pool their experiences for the benefit of all. The scope of AICUG was later on broadened to include others, and renamed as the Computer Society of India and formally registered on 6th March 1965 at Hyderabad.

- Organized a two-day workshop on “Evolution of Computing towards .NET 3.0 and Allied Technologies” on 26th & 27th February, 2007. The Branch also celebrated CSI Day on 6th March, 2007 with a Paper Presentation Contest on the theme “Affordable Computing”.

### **Valliammai Engineering College, Kattankulathur:**

- The Student Branch at the college was inaugurated on 24th March, 2007 by Mr S Ramasamy, Secretary, CSI Chennai Chapter. A Seminar on “Challenges and Opportunities in IT” was held on the occasion.

### **Vellore Institute of Technology, Vellore:**

#### **Vivekanand Education Society's Institute of Technology, Mumbai:**

- CSI-VESIT for its annual symposium held on 10th March, 2007 organized a lecture on ‘Bomb Detection and Safety’ by Mr S K Anthony, Senior Inspector of Police of the bomb detection squad, which included live demonstrations of explosions. The trained Labrador, Caesar who is an active member of the squad also thrilled the audience by his prompt obedience and ability to locate a bomb by virtue of his sense of smell. The CSI-VESIT's annual magazine “Interface” was launched on the occasion.

Reports of the activities received from the Student Branches concerned were published during the year in CSI Communications. However, it may be noted that many other activities conducted by the Student Branches during the year could not be mentioned due to non receipt of reports.

### **National and Regional Student Conventions**

#### **1. National Student Convention-2006**

The CSI Kolkata Chapter hosted the two-day CSI National Student Convention and Paper Presentation Contest on 23rd and 24th November, 2006 at Science City, Kolkata during the CSI-2006 Annual National Convention held by the Chapter. Fifteen papers were selected for presentation on these two dates out of the 52 papers received. On the basis of the evaluation of paper presentations prizes were given to students.



## 2. Regional Student Conventions

- i) **Region-I** : Students Convention on the theme “Enterprise Application Development Methodologies & Tools” was organized on 25th February, 2007 by CSI Delhi Chapter in association with Bharati Vidyapeeth’s Institute of Computer Applications and Management.
- ii) **Region-III** : Students Convention on the theme “Software Engineering Methodologies & Tools” was organized on 17th and 18th February, 2007 by CSI Ahmedabad Chapter in association with the Student Branch of Hemchandracharya North Gujarat University, Patan, Gujarat. The Convention included many students related events such as presentation /demonstration of innovative project work and programming contests in addition to debate and quiz competitions. It also had tutorials for students on Requirements Engineering, Software Estimation, architectures & Design, Software Inspection and Verification and Validation by eminent professionals and authors.
- iii) **Region-IV** : Students Convention was organized by the CSI Student Branch of the Institute of Management Studies, Rourkela in association with CSI Rourkela Chapter on the theme “Web Engineering” on 24th & 25th March, 2007. As part of the Convention a web design contest was held and an award for the best web design was presented.
- iv) **Region-V** : Students Convention on the theme “Security of Information Gathered & its Management (SIGMa – 2007) was jointly organized by the Student Branch of R V Engineering College, Bangalore and CSI Bangalore Chapter on 23rd and 24th March, 2007. It was inaugurated by Mr Ramachandra Gowda, Minister for Planning, Small Savings, Science & Technology, Govt. of Karnataka. The Convention had Invited Lectures, Technical Paper Presentations and other events like Technical Quiz and Programming.
- v) **Region-VII** : Students Convention on the theme “Pervasive Computing – The Technology and its Applications” was organized by the Student Branch of National Engineering College, Kovilpatti on 23rd and 24th February, 2007. The Convention had paper presentations, project demonstration, and programming / debate / quiz competitions. In the tutorial session, Mr K

G Srinivasan, dealt with the topic “Challenges: An Application Model for Pervasive Computing”. Dr S Arumugam, Regional Vice President, CSI (Region-VII) was the Chief Guest and released the Convention Proceedings and Nectnet V8 Magazine.

### Support for Student Activities

The Society is conscious of the fact that students of Engineering and Technology colleges are going to be the IT and other professionals of the future and to groom them into becoming good professionals they need to be given support and also provided opportunities and platform to interact with the industry and academia but these can essentially come only at a price. Hence, the ExecCom took the following important decisions concerning Student Branches.

- Provide financial support upto 1/3rd amount of annual student membership fee received from the Branch conducting activities.
- Provide Rs 50,000 (including seed money of Rs 15,000 ) to every Region to conduct Regional Student Convention at least once a year.
- Provide Rs 1,00,000 (including seed money of Rs 30,000 ) to hold an Annual National Student Convention at the national level during the CSI Annual National Convention.
- To encourage research, provide funding of good research projects of students, identified and approved by CSI.
- Provide Rs 50,000 to design and develop a portal for “CSI Adhyayan” for students.
- Nominate a National Student Coordinator who will coordinate student activities with the assistance of Regional Student Coordinators and others. He / She will be a permanent invitee to all meetings of the ExecCom and hence provided travel support etc.
- Provide additional budgetary support if needed, to Regional student Coordinators to encourage them to be more proactive.

The above decisions are expected to result in heavy financial implications to the Society but the ExecCom is strongly of the view that financial support is very essential if the Society is to ensure increase in student activities for the progress and growth of the students.

### CSI Events

The Society conducted National, Regional, Divisional and International events during the year at various locations

**Regional Training Programme**

A five days Southern Regional Training Programme on Open Source Software was jointly conducted by CSI Division-II (software), Centre of the International Cooperation for Computerization (CICC), Singapore, National Resource Centre for Free and Open Source Software (NRCFOSS), CDAC, Chennai and RMK Engineering College, Chennai from 22nd to 26th May, 2006. The training programme aimed to train the trainers in OSS and those trained would assist in the future training events to be organized by CSI in other parts of the country. The experience gained in organizing this first OSS training programme has given the confidence to plan to run similar events at other regions after identifying the

host institutions.

**Research Activities**

As part of its research activities the Society launched its scheme for R & D funding to help in carrying out minor research projects by Academicians / PG Students (Engineering Colleges and Technological Institutions) during the year. Details of the scheme was announced in CSI Communications and also uploaded in CSI website. The Expert Committee of CSI scrutinized the applications received and based on its recommendations the ExecCom approved to fund the research projects detailed in Table-6 below.

The CSI Education Directorate was entrusted with the responsibility of monitoring the implementation and progress of the above research projects in coordination with the Research Division of CSI. 50% amount for each of these projects was released in advance for implementation and further releases were based on the progress of the projects.

During the year the Department of Scientific & Industrial Research, Ministry of Science & Technology, Government of India, decided to accord renewal of recognition of Scientific and Industrial Research Organisation to CSI

for the period 01.04.2006 to 31.03.2009. Based on the renewal of recognition the Society has applied to the revenue authorities to grant the Society renewal of exemption for the period 01.04.2006 to 31.03.2009 from payment of income-tax.

**MOU with Sister Societies and Others**

CSI signed an MOU with Manufacturers' Association for Information Technology (MAIT) on 18th January, 2007 and an MOU with Institution of Engineers (India) on 5th March, 2007. Further, the Society signed an MOU with Microsoft



Corporation (I) Pvt Ltd on 9th March, 2007. The features and scope of these MOUs have been published in CSI Communications.

CSI's MOUs with Australian Computer Society, British Computer Society, Computer Society of Sri Lanka, Computer Society of Japan and Singapore Computer Society continued during the year. These MOUs primarily provide for reciprocal membership arrangements besides certain other facilities to each others' members.

### CSI Publications

CSI Communications, the monthly publication of the Society, was regularly published with the active assistance of Dr T V Gopal, Chief Editor, who strived hard to improve the quality of the publication and brought out the following Special Theme Issues during the year.

Dr Gopal exerted considerable effort in bringing out the special theme issues with the assistance of the Guest Editors concerned. The theme issues have not only contributed to enhancing the quality of the publication but also provided great value and knowledge to our members, though at a cost, since the special issues essentially contain more number of pages than normal and considerably increase the cost of the publication and contribute to the overall increase in the cost of servicing the membership. CSI Communications when published was also hosted on the CSI website for the benefit of the members.

Mr Lalit Sawhney, President (2005-'06) CSI, through his column "From the President's Desk" in CSI Communications, the mouthpiece of the Society, regularly

apprised the membership at large the plans, programmes and activities of the Society as also other issues of importance and interest to members.

Computer Science and Informatics, the quarterly Journal of the Computer Society of India, continued to enjoy its pride of place in the eyes of its readers because of the dedicated effort and hard work of Dr Manohar Chandwani, Editor, with whose assistance four issues of the publication i.e. Vol. 36 : 2, 3 & 4 and Vol. 37 : 1 were published during the year.

As Dr Chandwani completed his tenure as editor during the year Prof P V S Rao, Fellow and past President of the Society, has since taken over as Editor of the Journal.

### CSI Building at Chennai

The project implemented during the previous year for strengthening, renovating and expanding the existing CSI National Head Quarters Building at Taramani, Chennai made considerable progress during the year and based on the progress made the first phase of the project was expected to be completed and made ready for occupation by July 2007. The Society has allocated sufficient funds to ensure that further progress of the first phase is not handicapped. The project when completed will enable the Society to provide additional infrastructure to successfully increase the educational, student, research and other activities of the Society.

### Educational Activities :

- During the year the CSI Education Directorate at Chennai in association with SCTL, Pune conducted the CSI Software Testing Examinations at four centres (Bangalore, Mumbai, Indore and Pune) and awarded certificates. A total of over 1180 candidates were registered for these examinations which have since become very popular and a valuable asset to job seekers. In view of the increasing demand the frequency of these examinations have been increased and these are now held on the last Sunday of every month. The MOU with SCTL is in the process of being renewed so as to provide opportunities to more candidates to appear for these examinations for which the Directorate is planning to open more examination centres.
- Members may be aware that in view of the changes in the demand pattern in the IT field the holding of CSI National Standard Examinations had been suspended for quite some time as the Academic Committee of CSI was strongly of the view that conduct of these examinations should be resumed only after new syllabi is finalised. Accordingly, during the year the

Education & Research Division of CSI had drafted the syllabi for 10 core subjects and 3 electives. These were reviewed by 24 eminent Academicians and Practicing Professionals, and finalised. Since the new syllabi has been approved by the CSI Academic Committee and the ExecCom the Education Directorate is now in the process of re-launching the National Standard Examination.

- The Education Directorate has been conducting since the year 2003 Professional Examinations on behalf of the British Computer Society twice a year. Accordingly, during the year under review these examinations were held from 19.04.2006 to 03.05.2006 and 13.10.2006 to 18.10.2006 at Mumbai and Bangalore centres. A total of 35 candidates appeared in these BCS examinations conducted by CSI.
- For the courses conducted by CSI Nagpur Chapter for the employees of Maharashtra State Electricity Board and its Corporation, the Education Directorate conducted examinations on 25.06.2006, 10.09.2006, 10.12.2006 and 18.02.2007 and awarded Certificates to the 41 candidates who had successfully appeared.
- As in the past, the Education Directorate conducted on 19.10.2006 examination on WORD & EXCEL for the blind students of Victoria Memorial School for the Blind, Mumbai. A total of 25 students had registered for the examination of which only 16 qualified.
- During the year the Education Directorate conducted the CSI Young Talent Search Contest in Computer Programming. The selection process was quite elaborate. A total of 102 school teams, each of 3 students under the age of 17 years, had registered for the contest. After the first level regional contest held at 15 centres across the country and the final national level contest held at Chennai two school teams, one each from D A V Boys' Senior Secondary School, Chennai and Lilavatibai Podar Senior Secondary School, Mumbai were selected. The selected two teams were given extensive training at Rajalakshmi Engineering College, Chennai and taken to Colombo, Sri Lanka by a Chaperon from CSI for participation in the SEARCC International Software Programming Competition for School Students. In that competition held on 15.09.2006 several teams from SEARCC countries had participated and the Indian team from Lilavatibai Podar School won the First Prize and that from D A V Boys' School won the Third Prize.

Sending two school teams (each of 3 students) abroad along with the Chaperon, for participation in international competition entails considerable expenditure and the Society expresses its grateful thanks to the Sponsors Paharpur Cooling Towers Ltd, Kolkata, Satyabama Engineering College (Deemed University), Chennai, Tata Consultancy services Ltd, Chennai, and SCTL Integrated Solutions Pvt. Ltd, Pune for their magnanimous and timely assistance in making the participation by the school teams possible.

- Mr S Sudharssanam, CSI's Regional Director, Chennai had an interactive talk for about 50 minutes in All India Radio, Chennai on 07.06.2006 on the contribution of CSI in its four decades of standing since inception.

### **International Activities**

#### **1. IFIP**

During the year the Society submitted its bid to the International Federation for Information Processing to host the IFIP World Computer Congress-2010 in India. IFIP had received bids from several of its member countries to host the event. A two-member Site Inspection Committee of IFIP was scheduled to come on a two-day visit to India during the 3rd week of May, 2007 to see the sites offered by CSI

#### **2. SEARCC**

During the year CSI made efforts to continue SEARCC in the back drop of strong suggestions made by some SEARCC members to dissolve the organization. As a result of the efforts made by CSI the whole focus has since turned to continue SEARCC and conduct its activities. A final decision on these issues will be taken at the next SEARCC Annual Convention scheduled to be held in Bankok in November 2007 which CSI will be attending.

### **Celebrations of Independence Day and Republic Day :**

- Independence Day, for the first time was celebrated in CSI National Head Quarters Building at Taramani, Chennai on 15.08.2006. Maj. Gen A Balasubramanian, Fellow & Past President of CSI hoisted the National Flag. All the Officials of CSI at Chennai along with CSI members attended the function.
- Republic Day was celebrated in CSI National Head Quarters Building on 26.01.2007. Prof C R Muthukrishnan, Fellow & Past President of CSI hoisted



the National Flag and Maj Gen A Balasubramanian hoisted the CSI Flag. Several members from Chennai attended the function.

The Independence Day and the Republic Day will be celebrated every year in CSI National Head Quarters Building at Taramani, Chennai in future.

### Special Interest Groups of CSI:

SIG by its very nature is a focus group and its activity is national in character. The SIG membership is through email groups and essentially we should be able to enthuse academic and research community to participate. Though the SIG is having functional autonomy it should essentially be working with the concerned Division to be within the frame work of the CSI Constitution & Byelaws. During the year the following proposed SIGs were approved by the ExecCom.

### Elections

As in the previous year the CSI elections at the national level for the various elective offices for the year 2007-'08 / 2008-'09 were conducted electronically during the year. Simultaneously, some of the proposed amendments

to the CSI Constitution were also balloted and approved electronically. With the experience gained during the last two years in successfully conducting the CSI elections electronically the ' ExecCom is strongly of the view that Chapter elections too should be concurrently conducted electronically sooner than later. However, a final decision in this regard will be taken after studying the feasibility from all angles.

### CSI Website

During the year a contract was entrusted to M/s Sakshay, Delhi for the design and implementation of a new CSI website. The contractors had completed 90% of the coding by the end of the year. The new website is expected to be completed and commissioned after successful trials.

### Remembrance

1. Brig. V M Sundaram, the fourth President of CSI and Fellow passed away on 2nd June, 2006 at New Delhi at the age of 80 to the ravages of Cancer within a few months. 'Sandy' to friends, he was a brilliant cricketer, a speedy hockey winger, and a dashing fly-weight boxing champion. He was practical, unassuming and very outspoken to say the least. He was from Doon School, MCC and did his BE in Telecommunication from College of Engineering, Madras in 1948. He set up the EDP Centre at the Army Headquarters in Delhi in 1969 and was the architect of DOEACC. He joined CSI as the lead nominee of Army HQ Signals as an Institutional Member and was elected President CSI (1973-'74) when he successfully ushered CSI into the International Federation for Information Processing (IFIP). Later, in 1985 he was conferred the CSI Fellowship. In his passing away the Society has lost one of its senior professionals who will ever be remembered for his contribution and sustained support. A condolence meeting was held to pay him tributes at the CSI National Head Quarters at Chennai on 4th June, 2006 which was well attended by the CSI veterans and others.
2. Dr. S Srikantan, a Fellow and very ardent supporter of CSI passed away on 19th August, 2006 at Bangalore at the age of 74. He held a Ph. D in Electrical Engineering from Moore School, University of Pennsylvania, USA and was one among the true pioneers of the Information Technology industry in India in which he got involved in the mid sixties. He formed and led a group at the Atomic Energy Establishment, Trombay to design and develop digital computers for India and eventually took these designs into production at the Electronics Corporation of India.



He was a visionary and was deeply involved in R&D and in establishing a firm foundation for the growth of IT industry in India. In his passing away the Society has lost one more of its senior professionals during the year. He will ever be remembered in CSI for his useful contribution and support over the years.

### **Acknowledgement**

The overall performance of the Society during the year 2006-'07 was quite satisfactory in spite of several handicaps and unforeseen adverse circumstances. The

ExecCom has been making relentless efforts at improving the performance and enhancing the image of the Society further, and counts on the contribution and support of its members and all others concerned.

In conclusion, I take this opportunity to express my gratitude to the members, bankers, auditors, employees and all others concerned for their contribution, support and cooperation during the year.

# *Treasurer's Report*

It gives me great pleasure to present the Audited Annual Accounts of the Society for the year ending March 31, 2007 alongwith Auditor's Report. Members will kindly observe from the Auditors Report that the quality and procedure adopted for maintenance of Accounts are in uniformity with the requirements of the Public Societies Registration Act No. 1 of 1350.

The consolidated Balance sheet of CSI HQ and Chapters is given in the Annual Report. Many Chapters {refer Auditors Report point (4)} have not sent their accounts for audit, inspite of repeated reminders from Head Quarters about deadlines in submitting the accounts for audit. Hope that from next year onwards all chapters would submit their accounts for audit in time.

Total assets of the Society have increased to Rs 1030.84 lakhs as on 31.3.2007 as against Rs 962.20 lakhs as on 31.3.2006 registering an increase of Rs 68.64 lakhs during the year. The revenue surplus during the year was Rs 27.70 lakhs as compared to Rs 34.75 lakhs in the previous year.

This year, the attachments to the annual accounts includes a separate Region-wise P & L statement, which will be useful in improving the management of the society. Region I, III, V, VI and VII have registered an overall surplus during the financial year, whereas Region II and IV have an overall deficit. I would request and appreciate if the chapters in Region II (Assam, Bihar, West Bengal, North Eastern States and other areas in East and North East India) and Region IV (Jharkhand, Chattisgarh, Orissa and other areas in Central and South Eastern India) would put in more efforts and try to register a surplus in the next financial year.

Lastly, I take this opportunity to express my grateful thanks to the Executive Committee, Management Committees of the various Chapters of the Society and Finance Committees of major events for the co-operation extended during the year. I also thank the National & Regional Auditors and all the employees of the Society for their valuable service and support during the year.
